



## **CRCOG Weekly Legislative Report**

### **2018 Legislative Session**

**April 26, 2018**

#### **Weekly Legislative Feature Issues:**

This week in at the Capitol has been an eventful one with both chambers holding sessions on a number of days. Additionally, the Appropriations Committee released a budget proposal last week. Of particular note, this budget proposal was only supported by the House members of the committee and passed out of the committee with only a House favorable report. Subsequently, Speaker of the House Aresimowicz reported that he and the House Democratic leadership have begun holding budget meetings with his caucus members, which will continue through the weekend.

In other news, on April 25, 2018, leaders from Bridgeport, Hamden, and Torrington rallied at the Capitol to call for a remaining \$5 million in car tax reimbursements to be released by the state. Bridgeport Mayor Joe Ganim remarked that the failure to release these reimbursements has really blown a hole in budgets. He reported that Bridgeport had received \$3 million in supplemental car tax reimbursement money from the state with an additional \$3 million outstanding. Meanwhile, Torrington is owed approximately \$700,000 and Hamden is owed about \$1.2 million. The leaders noted that the loss of this revenue has forced them to make cuts including those to education and public safety services. Moreover, they reported that these towns have called on the General Assembly to keep its promise and to make the adjustments so the three towns can be properly reimbursed. At the end of their statement, they reported that their legislative leaders would be addressing these concerns during budget meetings with Speaker Aresimowicz.

**This past week has revealed new developments of particular interest to you:**

#### **Parties Sharply Divided Over Higher Ed, Labor Costs, Transportation**

Both Republicans and Democrats leaders in the General Assembly say that they can make amendments to a budget despite having just over two weeks left in the legislative session. With revenues \$1.09 billion higher than projected, the legislature is even less likely to pass tax increases. The Republican plan cuts spending by 0.7% while the Democrat plan increases it by 2.1% and exceeds the state's spending cap by \$31 million. Republicans argue that the Democrat's plan will lead to inevitable tax increases, most likely after this year's midterm elections. The Republican plan will cut labor spending while the Democrats argue that this is illegal. The Democratic budget would put \$26 million more in the transportation fund than Republicans proposed. The Republican budget would cut funding for UCONN and community colleges while the Democratic budget would maintain funding for UCONN and increase funding for community colleges. Both parties proposed additional funding to offset cuts to the Medicare Savings Plan and safeguards to prevent further cuts to municipalities.

### **Hartford Recovery Plan Falls Into Deficit After Three Years, Despite State Debt Payments**

According to the Municipal Accountability Review Board, Hartford is expected to run a \$2.5 million deficit by 2021, which is expected to grow to \$9.4 million by 2023, even with the bailout from the state. "The City of Hartford should be immediately classified as a Tier IV and should relook at going into bankruptcy," said Bart C. Shuldman, Chairman and CEO of Transact Technologies and member of the MARB. Luke Bronin, the Mayor of Hartford, maintains that Hartford can balance its budget with savings and economic growth. Malloy signed an agreement to pay \$550 million of Hartford's debt over the next 20 years, which has been denounced by both Republicans and Democrats in the General Assembly. Bronin said that Hartford filing for bankruptcy would be "bad for Connecticut." Hartford also wants to spend \$10 million on capital improvement projects but might not receive the money from the state or corporations to do so. Shuldman said that "clearly, once these payments end, the City of Hartford cannot fund their capital needs as the proposed 5-year plan goes into deficit in year four." He went on to add that the state might not have the "intent and wherewithal" to fund Hartford for five or more years.

### **CCM Trying to Protect Local Fund Balances in Final Two Weeks**

The Connecticut Conference of Municipalities (CCM) is trying hard to protect emergency funds for towns and cities. "Connecticut faces an unprecedented credit-rating crisis, with Moody's questioning the ratings of 26 additional cities and towns, adding to 25 already with negative outlooks," said Joseph DeLong, the Executive Director of CCM. They are lobbying for Senate Bill 421, which DeLong said "aims to protect the municipalities of Connecticut from passing the effects of these ratings down to the citizens of the state." The bill states that if a budget reserve 15% or less of the town's operating budget than it can not be used for an arbitration award. The planning and development committee already passed a bill which would prohibit arbitration panels from forcing municipalities use fund balances to pay for union agreements.

### **Hospital Tax Could Complicate CT Deficit, But Income Tax Receipts Keep Rising**

The deficit has almost doubled from \$198 million to \$363.5 million. This is because a new hospital taxing arrangement in which Connecticut is expected to receive \$150 million likely will not be decided until after the fiscal year ends on June 30<sup>th</sup>. Ben Barnes, Malloy's budget director said that if that's the case, "this will result in a shift of \$150 million from FY 2018 to FY 2019, making this issue budget-neutral across the biennium." He went on to add that "if federal approvals are not ultimately received, these hospital payments are subject to recovery by the state, thus mitigating any potential budgetary impact." Taxes on state hospitals are expected to increase from \$556 to \$900 million. However, it would produce

about \$200 million more in state payments. This year, Connecticut received \$665 million more in income tax revenues than expected. When all of the payments are received, it could receive up to \$1.03 billion ahead in revenues.

### **Hartford Bailout Maxes Out State's Credit Card—for Now**

House Minority Leader Themis Klarides (R-Derby) wrote a letter to State Treasurer Denise Nappier saying that the state would exceed the statutory bond limit by \$522 million because of the \$534 million that the state is providing to Hartford to finance its debt. Legislators from both parties thought that they were only providing assistance to Hartford for two years. "We only agreed to a two-year lifeline," said Klarides. Legislators from both parties were surprised to learn that the legislation provides debt assistance to Hartford for the next 20-30 years. Klarides added that "this was a deal that was done in the dark of night." Chris McClure, a spokesperson for Governor Malloy, said that "the language the legislature drafted and passed, with the vote of Representative Klarides ... stated that contract assistance agreements would constitute a full faith and credit obligation of the state. This was not ambiguous then, and it is not now." The only three alternatives to exceeding the cap are "delay[ing] or cancelling planned bonding], raising taxes or revenues, vot[ing] to modify the debt limit statute and grant an exception for the emergency aid for Hartford." The first alternative is unpopular among Democrats, while the second and third alternatives are unpopular among Republicans. Klarides said that if projects have to be cancelled then those in Hartford should be cancelled. House Majority Leader Matt Ritter (D-Hartford) said that exempting the aid for his city from the statutory bond limit was the best solution.

### **Toll Vote Expected Next Week**

House Speaker Joe Aresimowicz (D-Berlin) is proposing a vote on tolls next week. He understands that they will likely face unanimous opposition from Republicans. He said that they are the "party of no tolls and crumbling infrastructure that makes us not competitive with neighboring states" and that they're the party of "... sorry that that bridge collapsed." The Connecticut Republican Party issued a press release stating that "Connecticut Democrats are moving forward to add tolls to state roadways. As if the Democratic Party has not cost Connecticut's workers enough, they will be making the commute to work more expensive." Aresimowicz added that he's "no longer afraid of the toll argument at all" and that "he's willing to do the right thing for Connecticut and let the pieces fall where they may." Aresimowicz specifically mentioned that \$40 million has been spent to patch up a crumbling exit ramp off of Interstate 84 right by the Legislative Office Building's parking garage. Governor Malloy has proposed a 7 cent hike in the gas tax but this has not been discussed among legislative leaders. Aresimowicz added that leaders should be prepared to use money from the Rainy Day Fund to keep the Special Transportation Fund solvent.
