Weekly Legislative Feature Issues:

As the public hearing phase of the legislative session begins to wind down, committees have begun holding meetings to take final committee action on bills. Among these was **SB No. 806**: AN ACT ALLOWING MUNICIPALITIES TO ESTABLISH A GRANT PROGRAM TO REPLACE OR REPAIR CONCRETE FOUNDATIONS, which was voted out of the Public Safety and Security Committee on Wednesday, March 15, 2017. This bill will continue moving forward for further action. Meanwhile, the Finance, Revenue, and Bonding Committee and the Appropriations Committee continue to progress through the budgeting process holding meetings to receive agency budget presentations and working sessions to develop a clearer understanding of current and projected agency needs.

2017 Legislative Session in the News:

State pension fund jumps 13.4%

According to the State Treasurer's office, the state pension fund yielded a 13.43% net return on its investment over the past 12 months ending on January 31, 2017. Of particular note, the market value of the \$30.89 billion Connecticut Retirement Plans and Trust Funds for teachers and state employees increased by \$830 million between October 31, 2016 and January 31, 2017. State Treasurer Denise Nappier attributed this increase to the "bullish equity markets since President Trump was elected," which according to her has been "driven largely by expectation of favorable tax policies, deregulation, and increased spending on infrastructure."

Public Safety and Security Committee Votes SB 806 Out of Committee 3-15-2017

The Public Safety and Security Committee voted 19-6 with no members absent and not voting to move, [S.B. No. 806](#) AN ACT ALLOWING MUNICIPALITIES TO ESTABLISH A GRANT PROGRAM TO REPLACE OR REPAIR CONCRETE FOUNDATIONS. (PS) **JFS to Floor**, out of committee. This bill will now move forward for further action.

- Sen. Miner introduced an amendment, which was adopted, that would sunset the additional \$12.00 annual tax levy on homeowner's insurance on October 12, 2025.
- Rep. Fishbein opposed the bill as a bailout.

Partisan Bickering Over Budget Deadlines Continues

In a letter delivered to Democratic legislators last week, Senate Republican President Len Fasano called on Democrat in the legislature to agree to a May 5th budget deadline, which he argued would give cities and towns the predictability they need to develop and approve their own municipal budgets. Governor Malloy replied to Senator Fasano and House Minority Leader Rep. Themis Klarides, "If you believe that a May 5 deadline is not only appropriate but achievable, it follows that your own budget would be ready in the very near future." Rep. Klarides said that her members are fully engaged in the budget process and she expects that her caucus will offer alternatives to the governor's proposed tax and spending plans, but gave no specific date. Senator Fasano pointed out that since 2011, Republicans have put forth 12 budget alternatives, but declined to provide specifics nor a date on which a Republican alternative would be released.
