## Launch Event Summary

On May 19, 2017, Connecticut Governor Dannel Malloy joined Connecticut Department of Transportation Commissioner James P. Redeker and State Farm Vice President-Agency Matthew Hodson to announce State Farm sponsorship of its Connecticut Highway Assistance Motorist Patrol (CHAMP) program. The program will be renamed the "CTDOT State Farm Safety Patrol." With this launch, Connecticut joins a roster of seventeen states that benefit from sponsorship of their Safety Patrols.

The announcement, which generated significant news coverage, was held outside of the Capitol building in Hartford, CT. It was well attended by DOT and State Farm representatives, the Federal Highway Administration (FHWA), State Police, and local media. Speakers included:
