Bruce suggests doing regularly scheduled notice drills using the required paperwork needed to be filled out, and then follow with unannounced drills. It was strongly encouraged to the group that they become intimately familiar with the Appendix B- Communications protocols... since this is what we as a Region do... 3 C's- communicate, coordinate, and collaborate.
  - Everbridge update- needs to get contract moving. Need locals to send contact information in excel format. To date Carmine has received only one list from one local health department. Will need to look at nomenclature for what LHDs call their lists. Ad hoc workgroup may need to be developed. Deadline for contract end of June.
