Subject: Staff Recommendations - 2018 LOTCIP Fast Tracking Projects

In response to CRCOG's request to fast track up to \$5 million in Local Transportation Capital Improvement Program (LOTCIP) projects we offer the following for your consideration, discussion and action at the upcoming July 23, 2018 Transportation Committee meeting (acting on behalf of the Policy Board).

CRCOG staff is pleased with the overwhelming commitment from 14 towns to accelerate designs in a compressed timeframe for over \$24 million in projects. These commitments assist us with our overall goal of programing LOTCIP funds within our region during Fiscal Year 2019. The following summarizes the specific towns that expressed an interest and commitment to fast tracking their projects:

CRCOG staff assessed each of the submitted projects for purpose and need and a municipality's ability to adhere to an accelerated design schedule. The following table summarizes CRCOG staff LOTCIP fast track project recommendations. These recommendations fit within our original framework to advance up to \$5 million under the fast tracking initiative.

A couple of supplemental items that the Transportation Committee / Policy Board may want to understand as we consider endorsement: (1) Hartford and Newington have not received LOTCIP money under previous solicitations and have expressed sincere commitments to advancing quickly; (2) Rocky Hill and Windsor have a successful track record of advancing projects in an efficient, streamlined manner.

## Recommendations

CRCOG staff recommends that we endorse the Hartford, Newington, Rocky Hill and Windsor projects (referenced in Table 2) for fast tracking and work to immediately move them into LOTCIP. If endorsed, CRCOG staff will work with these municipalities to immediately complete any LOTCIP application gaps and gather supplemental information (e.g. pavement cores). Following this, CRCOG will work to transmit these applications to CTDOT requesting commitment to fund letters by September 30, 2018.

CRCOG staff further recommends that we remove these projects from the latest solicitation and rankings. Shortly after endorsement of fast tracked projects, CRCOG staff will release preliminary rankings for the balance of projects for further discussion and action. Given that we received over \$24m in letters from towns wanting to accelerate designs, CRCOG staff will work to understand how we can advance other projects in a streamlined manner.

Finally, CRCOG will continue assessing our regional LOTCIP funding and innovative ways to program funding and continue ramping up expenditures.
