

Prior to her appointment Emily held positions in the CRCOG Transportation Department and Policy and Planning Department and as Associate Planner at the Regional Plan Association. In those roles she has worked on numerous transportation corridor studies as well as transit-oriented development, complete streets planning, the CRCOG Regional Plan of Conservation and Development and the first Connecticut Mayor's Institute for RPA.

Emily is Immediate Past President of the Connecticut Chapter of the American Planning Association (President 2013 to 2016). The current CCAPA's President, Michael Piscitelli states, "Emily is a key influencer in the planning community. She has earned a reputation statewide as a forward-thinking professional planner with the credibility and ethics to carry-out major initiatives. Emily has the trust of her peers, which is indicative of her passion and commitment to our field. She is well-practiced and organized to manage a large group of people from diverse backgrounds, and is known to be well-prepared, thoughtful and smart."
