

# MetroHartford Brownfields Revolving Loan Fund Program



### **Program Facts:**

- The MetroHartford Brownfields Revolving Loan Fund (RLF) is a loan program repayment is required (Grants may be available to municipalities)
- RLF monies can only be used to pay for remediation/cleanup activities
- Funds are provided through the US EPA to CRCOG



Imagine the Possibilities...

#### **Eligibility Facts:**

- Property must have contamination from Petroleum or Hazardous substances
- Borrowers must own the property or demonstrate a legal interest in the property and must retain ownership throughout the term of the loan
- Property must be entered into a state Voluntary Remediation Program
- Borrower must demonstrate credit worthiness and ability to repay the loan
- Borrower must not be a potentially responsible party
- All environmental site assessments must be completed

## Financial Facts:

- Repayment terms are negotiated on a project by project basis Deferment may be arranged
- Competitive interest rates
- Funds can be used in combination with other financing sources and can provide essential "gap" financing
- Minimum match of 20% may be required
- Davis-Bacon Wages are required



#### **Eligible Uses of RLF Funds:**

- Cleanup planning
- Excavation, consolidation, or removal of contaminated soils
- Containment, treatment and disposal of hazardous materials
- Removal of drums, barrels, tanks or other bulk containers that contain or once contained hazardous substances
- Site monitoring, including sampling and analysis necessary during the cleanup process
- Installation of security controls such as fencing, drainage controls
- Capping of contaminated sites





Real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant. (US EPA)

Any abandoned or underutilized site where redevelopment, reuse or expansion has not occurred due to the presence or potential presence of pollution in the buildings, soil or groundwater that requires investigation or remediation before or in conjunction with the redevelopment, reuse or expansion of the property. (State of Connecticut)
