**March 2, 2017**

### **Weekly Legislative Feature Issues**

In the past week, there have been several significant developments both at the Capitol and throughout the Greater Hartford region. The Appropriations Committee concluded its series of agency budget presentations and public hearings on Governor Malloy's proposed budget and have now begun holding work sessions with the executive agencies as they continue developing a legislative budget proposal.

On Monday, February 27, 2017, MMCT Venture LLC, the joint venture between Connecticut's Native American Tribes, the Mohegans and Mashantucket Pequots, announced that they had selected East Windsor as the location for a third casino aimed at curbing the impact of MGM's casino development underway in Springfield, MA.

In Hartford, a joint public hearing was held on Crumbling Foundations in which members of the public as well as public officials were given an opportunity to be heard on a host of bills relating to this ongoing crisis.

Finally, in another significant development, there were the special elections of Eric Berthel and Douglas McCrory to serve in the state Senate and Dorinda Borer to serve in the House of Representatives.

### **2017 Legislative Session in the News**

#### **Hartford area one step closer to having a National Park**

On Monday, February 27<sup>th</sup> it was announced that the Coltsville National Park plan cleared a hurdle in Congress. The House of Representatives approved a change related to the site of the park's headquarters. By a vote of 369 to 42, legislation now allows the headquarters to be located in two brownstone buildings that were a part of the original Sam Colt factories. They are all that remain of the factories. The original legislation from 2014 required the headquarters to be under the iconic blue dome. Rep. John Larson, D-1<sup>st</sup> District, introduced the original measure and the new legislation. One of the birthplaces of the industrial revolution, the measure must still be passed by the Senate and signed into law by the White House.

### **Tribes Pick East Windsor for Third Casino**

On Monday, February 27, 2017 the joint venture between the Mohegan and Mashantucket Pequot Tribes (MMCT Venture LLC) announced that they have chosen the former Showcase Cinemas off I-91 in East Windsor as the location for the third casino, which would be the state's first casino off tribal land. This announcement came after a 5-0 vote by the East Windsor Board of Selectmen during a meeting held on Saturday allowing the project to move forward. The East Windsor location was chosen over two locations in Windsor Locks.

Sen. Tim Larson, who represents the district, said that "It's not that East Hartford or Hartford didn't win the casino — Connecticut won the casino which will generate revenue, create and retain jobs, and add to our tourism portfolio," Larson said.

### **Unofficial Results by Town in the Special Elections**

On Tuesday, February 28, 2017, there were three special elections held around the state to fill vacancies in the 2<sup>nd</sup> Senate District (Hartford, Bloomfield, and Windsor), 32<sup>nd</sup> Senate District (Oxford, Roxbury, Seymour, Washington, Watertown, Woodbury, Middlebury, Southbury, Bethlehem, and Bridgewater) , and the 115<sup>th</sup> House District (West Haven) .

The Secretary of State's office released unofficial results, which are identified below:

- Douglas McCrory, a Democrat and previously a sitting member of the state House of Representatives defeated Michael McDonald (R), Charles Jackson, and Aaron Romano with 72% of the vote.
- Eric Berthel, a Republican and also a previously sitting member of the House defeated Greg Cava D and Daniel Lynch (petitioning candidate) with 54% of the vote.
- Dorinda Borer, a Democrat defeated Edward Granfield (R) with 61 percent of the vote.
