**Public Health**

Healthcare Coalition Update:

Have gotten about half of the SBP1, and BP3 reports that are needed. Going to establish a singular email address for HCC report submissions.

At Risk Populations Project, is one of our deliverables, will be starting with Tetrattech soon. A four-phase approach to this project including survey of needs/gaps, baseline assessment of plans, access and functional needs workshop and discussion based scenario, strategic planning/road map of how we go forward.

Common information sharing platform evaluation next week by a core group. Alternative dates have been set for the live ICS courses with no responses as of yet.

Coalition Surge Test for region 3 will be at Bristol Hospital, 124-bed hospital. Exercise will be a full building evacuation. Bristol Hospital will have to stand up the EOC, go for 90 minutes.
