Mark Massaro of Eversource introduced himself and thanked municipal officials for their patience during the recent windstorm regarding power restoration in their towns.

3. Approval of Minutes from January 30, 2019:

Dr. Wray reviewed the letter from CRCOG requesting Congressman Neal's office to request that MassDOT expand the East-West Passenger rail study scope to recognize shared economy and the large passenger market in our area.

Jonathan Harris, OPM

Jonathan Harris, Undersecretary OPM, discussed House Bill #7192 *An Act Concerning Municipal and Regional Opportunities and Efficiencies*. He talked about the proposal for shared assessment services within the COG's, stating this could result in better data sets and more accurate assessments, as well as cost savings for municipalities.

Discussion followed. Jonathan Harris answered a variety of questions from Board members.

Executive Director Dr. Lyle Wray provided this update to the Board. He asked if the Board had any questions regarding his monthly report. There were no questions.

c. Municipal Services and Purchasing Council

Peter Souza provided the following update to the Board:

- CRPC opened Fuel Oil on 2/21, bid tabulation is posted on our website and we are currently soliciting requirements for Swimming Pool & Water Treatment Chemicals and Bituminous Class 1 and 2 and Curb Mix. Requirements due March 4th.
- The next Human Services Coordinating Committee meeting will be held on Monday, March 11th, and we will have speakers from the FBI and DCF on the subject of Human Trafficking.
- CRCOG signed an amendment with NOVUS Insight (formerly CCAT) to add on Cybersecurity Programs (assessment, remediation, maintenance and training).

- Old Lyme signed this month to the Regional Online Permitting Program bringing the total to 47 towns.

d. Policy and Planning

Emily Hultquist provided this update to the Board.

e. Public Safety and Homeland Security

Joyce Stille provided this update to the Board.

Public Safety staff arranged for a Basic First Aid/CPR Certification course for the office which was held last week. 17 CRCOG staff members are now certified in CPR and the use of an AED.

Per the request at the last meeting the First Hour Emergency Checklist for Elected Officials and senior staff is now available on the CRCOG website

DPH is encouraging regions to consolidate mass dispensing areas. We have begun that discussion in our region with Emergency Support Function 8 – Health and Medical Services. They are pursuing a recommendation to have one MDA in our region.

John Elsesser requested that CRCOG look in to the "Stop the Bleed" program." He feels this is an important topic and would like to see CRCOG facilitate this for municipalities. Scott Shanley concurred regarding the importance of this awareness. Dr. Wray said that CRCOG will look in to this and will report back to the Board.

f. Transportation Committee

Jon Colman provided this update to the Board:

LOTCIP

One cost increase was approved for the Suffield Multi-Use Trail (Route 168).

 Staff prepared an analysis of all LOTCIP project cost histories. A total of 24 CRCOG projects have received Authorization to Award Letters. CRCOG initially approved \$29.2 million of LOTCIP funding for these projects. Final Authorization to Award amounts totaled \$29.5 million, or approximately 1% more than the initial solicitation award. This is a testament to the knowledge of the town staff who prepare the applications.

Eversource Utility Relocation Charges to Municipalities

• Transportation Committee discussed Eversource's latest policy guidance table regarding cost reimbursement for utility relocations. A request for clarification was previously transmitted to Eversource by Mr. John Elsesser, Coventry Town Manager, and a response was expected by February 15th. No response has been received. Transportation Committee passed a motion for Policy Board to file a complaint with the Public Utilities Regulatory Authority (PURA), as appropriate. Mr. Elsesser noted that the individual from Eversource that he'd been coordinating with has been dealing with the recent windstorm and that he will follow-up.

Metropolitan Transportation Plan and Air Quality Conformity Analysis

 CRCOG's Metropolitan Transportation Plan (MTP) and CTDOT's Air Quality Conformity Analysis (AQCA) are currently open for a 30-day public comment period. The State performs the AQCA on a statewide basis, and analysis shows that the documents are within conformity levels. Full documents are available on the CRCOG website, and comments can be sent to Tim Malone by March 22nd.

Mayor Leclerc stated she would like to have Transportation Commissioner Joe Giulietti attend a future Board meeting. The Board members concurred. Dr. Wray will work on arranging this.
