1. Call to Order: Chairperson Marcia Leclerc called the meeting to order at 12:00 pm.

2. Public Comment:

Mark Massaro of Eversource stated that Eversource has launched its first application which will allow customers to access several on line options such as bill pay, outages, etc. The app is called *Eversource Energy*.

3. Approval of Minutes from April 24, 2019:

Chairperson Marcia Leclerc requested a motion to adopt the minutes.

Jon Colman made a motion to approve the Policy Board Meeting minutes from April 24, 2019. Lori Spielman seconded the motion and it carried unanimously.

Mayor Leclerc addressed action items 7-9 next on the agenda.

ACTION ITEMS:

7. Action: CRCOG FY 2019-2020 Budget

Pauline Yoder presented CRCOG FY 2019-2020 budget highlights with the Board. Dr. Wray explained that CRCOG has a balanced budget providing financial stability for the next few years. He stated that this budget was approved by the Executive Committee at it's May 8, 2019 meeting.

Jon Colman made a motion to approve the CRCOG FY 2019-2020 Budget as presented. Dave Kilbon seconded the motion and it carried unanimously.

8. Action: Adoption of 2019-2024 Capitol Region Natural Hazard Mitigation Plan

Lynne Pike-DiSanto presented the proposed 2019-2024 Capitol Region Natural Hazard Mitigation Plan to the Board. The presentation may be viewed [here](#).

Jon Colman made a motion to adopt the 2019-2024 Capitol Region Natural Hazard Mitigation Plan as presented. Joyce Stille seconded the motion and it carried unanimously.

9. Action Resolution Authorizing Contract Award for E-Procurement System

Dave Kilbon made a motion to approve the resolution authorizing the contract award to Bonfire for E-Procurement System as presented. Jon Colman seconded the motion and it carried unanimously.

At this time, Mayor Leclerc welcomed and introduced Pam Sucato, Thomas Maziarz and DOT Commissioner Joseph Giulietti. Mayor Leclerc addressed the tolls presentation as the next item of business.

6. PRESENTATION / UPDATES:

- **Presentation on Tolls, Thomas Maziarz, CTDOT**

Thomas Maziarz provided a detailed and informative presentation on the proposal of the implementation of tolls in Connecticut. He discussed gantries, toll rate structure and revenues and provided a [handout](#) on related projects in the capital region.

Commissioner Giulietti explained that there is a lot of misinformation going around regarding this matter. He stated that implanting tolls is the closest option to a user fee that can be done. The Commissioner expressed the importance of sharing the information provided in the presentation, emphasizing that the STF is still in a state of financial crisis and has not been resolved by any means. Pam Sucato pointed out that without tolling, major transportation projects across the state will be delayed.

Mayor Leclerc suggested DOT create a webinar explaining the information provided in the presentation to help individuals understand the reasoning behind the proposed execution of tolls. The Board concurred this is an excellent idea.

Joyce Stille suggested a slide be added to the presentation that answers the frequently asked question of how tolls will impact federal funding. Commissioner Giulietti and Tom Maziarz explained that federal funding will not be impacted.

Discussion ensued, and the Commissioner and Tom Maziarz answered questions from the board.

Dr. Wray pointed out that with the new car sales tax and additional bonding have been taken away, stressing that the STF is not fixed. Dr. Wray will send the presentation to the Board, so they may share it among their municipalities.

Mayor Leclerc and Dr. Wray thanked the Commissioner and Tom Maziarz for their time at the Policy Board meeting.

- **U.S. Census Complete Count, Catherine Marx, U.S. Census Bureau**

Catherine Marx, U.S. Department of Commerce, U.S. Census Bureau, Partner Specialist, spoke about the 2020 Census. The decennial Census goal is to count everyone once, only once and in the right place. Census data is used to reapportion the House of Representatives (mandated in U.S. Constitution), redistricting State legislative districts and the distribution of more than \$675 billion in federal funds to the states. Catherine stated that many communities for forming Complete Count Committees (CCC) to assure that their towns have an accurate count. To conduct the 2020 Census community partners are needed to influence, educate and promote the census locally. While Catherine will reach out to individual towns, there was some discussion on forming a CRCOG CCC.

- **Capitol Regional Natural Hazard Mitigation Plan, Lynne Pike Di-Santo, CRCOG**

f. Transportation Committee

Jon Colman provided this update to the Board.

- Eversource Utility Relocation Charges – (John Elsesser was at the meeting with Eversource and may want to give the update) CRCOG sent a letter to and met with Eversource representatives. Eversource indicated that municipalities would not be charged for relocations on LOTCIP projects. CRCOG sent Eversource documentation of their representatives indicating that municipalities would be reimbursed if incorrectly charged. Eversource requested that CRCOG propose an appropriate limiting timeframe when municipalities can submit requests for reimbursement. Additional outstanding issues are being followed up on.
- LOTCIP - CRCOG staff will be meeting with CTDOT regarding some municipal concerns & potential solutions related to the CTDOT LOTCIP program
- BUILD Grants – US DOT announced a Notice of Funding for \$900 million in Infrastructure Grant Funds. Minimum award is \$5 million for urban areas and \$1 million for rural areas. Maximum award is \$25 million. Historically a local match equal to or greater than the award amount is required to be competitive.
- Transportation Alternatives Set-Aside Program – The region received eight (8) applications and staff short-listed five (5). The five municipalities will present at a June 3rd Special Transportation Subcommittee meeting for ranking by peers. The three (3) top ranked projects will be submitted to CTDOT as CRCOG's selections for funding assuming this program continues to be federally funded.
