Subject: ***Metropolitan Transportation Plan 2019-2045***

As you know, CRCOG is in the process of updating the region's Metropolitan Transportation Plan. This plan lays out a vision for the region's transportation system to the year 2045. It also establishes priorities for spending federal transportation dollars allocated to the region.

CRCOG has developed a draft of this plan which was released for a thirty-day public comment period on February 20. The comment period ended on March 22 and included two public meetings on March 12 and March 14. During development of the plan, two other public meetings were held in December. This is in addition to over a dozen stakeholder interviews and focus groups.

All comments have been reviewed and incorporated as appropriate. We are now looking for endorsement of the attached resolution adopting the plan, which will be acted on by the Policy Board on April 3, 2019. RESOLUTION ADOPTING THE 2019-2045 METROPOLITAN TRANSPORTATION PLAN

WHEREAS, the Capitol Region Council of Governments (CRCOG) has prepared a Metropolitan Transportation Plan (MTP) for the years 2019 through 2045; and

WHEREAS, the MTP is primarily a systems level plan that provides general policy guidance, defining the Region's greatest needs, identifying which problems are the Region's highest priorities, and recommending how the Region should spend its limited capital funds; and

WHEREAS, the MTP also incorporates the recommendations of many special studies previously undertaken and endorsed by CRCOG; and

WHEREAS, residents and businesses were afforded opportunities to comment on the MTP by mail, email, phone and through four public meetings; and

WHEREAS, comments received have been addressed in the final draft Plan; and

WHEREAS, the 30-day public comment period (February 20 to March 22, 2019) for the MTP is consistent with CRCOG's Public Participation Plan and its Limited English Proficiency Policy; and

WHEREAS, the CRCOG Transportation Committee has reviewed the Plan, approved modifications to the original draft Plan, and has endorsed the final draft Plan;

NOW THEREFORE BE IT RESOLVED THAT, the Capitol Region Council of Governments adopts the 2019-2045 Metropolitan Transportation Plan.
