*“Slow Down - Move Over - Be Safe”*

**Hartford, CT, November 5, 2021** – Ned Lamont, Honorable Governor of the State of Connecticut, officially proclaims the week of November 8-14, 2021, as Crash Responder Safety Week (CRSW), formerly known as Traffic Incident Response Awareness Week.

The awareness campaign is being held across the country to raise awareness of the importance to **SLOW DOWN, MOVE OVER** for any vehicle with flashing lights on the highway.

It’s vital to remember that personnel responding to a crash provide a critical public service and are called to duty at all hours of the day and night, in adverse weather conditions, and in dangerous roadside environments. Their safety and the safety of those involved are paramount.

Sadly, too many crash responders have been struck and either injured or killed while responding to or working at a crash scene.

[The Greater Hartford Traffic Incident Management Coalition \(GHTC\)](#) encourages everyone to support those who put their life on the line 24/7/365 days a year. There is a unified team that works closely together to make sure the right people show up to the scene to help move cars and trucks out of the roadways and save lives. Firefighters, EMS/EMT, law enforcement, towing and recovery professionals, safety patrols, maintenance crews, commercial vehicle squads, environmental and hazmat crews, traffic management centers, 911 dispatchers along with the media work together to respond quickly and safely.

While all 50 states have “*Slow Down, Move Over*” laws, recent surveys show that currently fewer than 30 percent of Americans know these laws, according to the National Highway Traffic Safety Administration. Millions of motorists are passing near or through a crash scene, and it is important to know what to do when approaching or being involved in one.

## REMEMBER

**Slow Down-Move Over** – In Connecticut, [the Move Over law](#) requires motorists to slow down and move over for emergency and maintenance vehicles and disabled motorists if safe to do so.

**Move It (Steer It-Clear It)** – In Connecticut, [the Move It law](#) requires motorists involved in a traffic incident to safely move their cars out of the roadway if the vehicles are drivable and there are no injuries.
