SUBJECT: Project Prioritization

In October 2020 CRCOG issued a request for projects for year 3 of the Statewide Active Living Active Transportation Project, or ActiveCT. The solicitation closed on November 20, 2020. We received seven (7) applications for standard projects, six (6) applications for bike racks (including a regional application), and five (5) applications for the "Train the Trainer" educational program.

Methodology

To prioritize the projects, CRCOG staff analyzed the projects in relation to the following categories and assigned them weighted scores:

Category	Max Points	Data
Population Served	5	Population data from Urban Footprint (based on Census data)
Jobs Served	5	Job data from Urban Footprint (based on LEHD)
Geographic Diversity	10	Region or municipality without a previous project
Benefits to Sensitive Populations	10	Census data on: low-incomes (less than 150% of poverty); minorities (non-white); population over 65; population between 5 and 17
Health Equity	10	EPA Percentile Index For Air Toxics Respiratory Hazard
Proximity to Everyday Destinations	5	WalkScore.com
Project Type	5	Whether the project enhances an "everyday destination"

Raw data form each category was transformed into a percentile index and points were assigned based on the percentile rank.

Recommendation

Originally it was our intention to just select projects for year 3 and conduct a subsequent solicitation for years 4 and 5. Upon reviewing project proposals, however, we have determined that segmenting projects by funding year will be difficult due to uncertainties related to project costs, scopes, and schedules. Instead of selecting a few projects for year 3 and then resoliciting projects for year 4, we recommend creating a prioritized list of projects that would be completed as funding and project schedules allow. Under this scenario, all projects that were submitted in this solicitation would eventually be completed, many in year 3, but some in year 4. As projects are completed, additional projects would be solicited and added to the list.

A prioritized list of projects is below. We are recommending that the Killingly project be prioritized first as NECCOG did not receive a project in the first two years of the program.

For the "Train the Trainer" applications we had originally planned to do up to 10 programs. Since we only received five application we recommend funding them all. The applications included: Canton, Mansfield, Meriden, Thompson, and a regional application for SCCOG. An inquiry from Middletown was also received after the close of the application period. We recommend giving them a workshop as well if they are still interested.
