The overlay will need to be replaced by the time of construction and the deck will be patched and a new membrane will be applied before resurfacing. The preformed joint seals need to be replaced and repairs to the deck ends should take place at that time. The approach barriers need to be realigned to address vertical and horizontal misalignment and spalls in the underside of the precast concrete superstructure need to be addressed.
