- **1. Roll Call 0:00** –The meeting was called to order at 12:01 pm by the Chair Jon Colman from the Town of Bloomfield. Ms. Karen Stewartson conducted the roll call.
- 2. Public Forum 4:09 No one chose to speak
- **3.** Adoption of Meeting Minutes from February 14, 2022 4:20 A motion was made by Patrice Carson from the Town of Bolton, seconded by Tom Roy from the Town of Simsbury, to accept the minutes from the February 14, 2022 meeting. This motion was passed unanimously with two (2) abstentions by Tim Webb from the Town of Ellington and Todd Rolland from the Town of Somers.

## 4. Staff Report

- **60 Seconds for Safety: Training Opportunities 5:17** Mr. Roger Krahn shared that traffic deaths have been increasing. Mr. Krahn noted that upcoming training sessions via UConn's T2 Center are focused on traffic safety. These sessions will on Speed Management will be held in April, May, and September. - State Legislative Session: Transportation-Related Items 7:55 Mr. Roger Krahn noted that the meeting materials included a list of and links to transportation-related bills being considered by the Connecticut General Assembly.
- **LOTCIP Solicitation Project Proposals 8:35** Ms. Sotoria Montanari shared the list of projects that staff is reviewing under the 2022 solicitation. Ms. Montanari stated that staff rankings will be presented to the Cost Review Sub-Committee in April, and she noted that staff will be following up with Towns if more information is needed.
- **The Trail Fund 10:13** Mr. Tim Malone shared information about The Trail Fund, which will offer small grants for trail maintenance, research, and stewardship training projects. The application deadline is April 15, 2022, and more information is available at <a href="https://www.americantrails.org/apply-for-the-trail-fund">https://www.americantrails.org/apply-for-the-trail-fund</a>.

## Other

- RAISE Grant **11:20** Mr. Robert Aloise shared that the new Federal transportation bill (IIJA) has been funded, including the RAISE Grant program. Mr. Aloise stated that CRCOG is working with New Britain and Plainville on RAISE application. Mr. Aloise shared that a resolution allowing CRCOG to submit this application will be presented to the Policy Board without Transportation Committee action because the resolution was not on the agenda. Mr. Aloise asked if the Committee had any comments about the resolution to be shared with the Policy Board. There were no comments.
- Executive Director 14:20 Mr. Matt Hart gave a brief update on his initial weeks as CRCOG's new Executive Director.
- **5. TIP Amendments 15:52** Mr. Rob Aloise reviewed the TIP Amendments. A motion was made by Patrice Carson from the Town of Bolton, seconded by Rob Trottier from the City of New Britain, to approve the TIP Amendments. This motion was passed unanimously.

- **6. LOTCIP Funding Increase** / **Scope Modification Request 18:15** Ms. Sotoria Montanari reviewed one (1) LOTCIP funding increase request. Mr. Larry Baril from the Town of Avon shared additional information about the request. Committee members asked some questions regarding local public support for roundabouts as well as the role Avon Old Farms school has played in this project. There was also a discussion about the impact cost increases have on the overall LOTCIP budget. A motion was made by Patrice Carson from the Town of Bolton, seconded by Chris Edge from the Town of Berlin, to approve the increase. This motion was passed unanimously.
  - Avon Old Farms Road-North South Section (L004-0001): Funding increase of \$1,732,076 from \$3,378,000 to \$5,110,076 (51.2% increase)
- 7. Other Business 37:12 Dr. Lyle Wray raised a question regarding funding for the Hartford Rail Line. Mr. Robert Aloise mentioned that they are two meetings scheduled with CTDOT related to their Capital Plan and that he will keep the Committee updated.
- **8. Adjourn 38:58** The meeting was adjourned at 12:40 pm via a motion by Patrice Carson from the Town of Bolton, seconded by Chris Edge from the Town of Berlin.
