



Quarantine and and Isolation

- Medication and medical needs.
- Mental and behavioral health support.
- Technological assistance i.e. providing elders with the ability to remain connected.
- Financial assistance.
- Volunteer outreach communicate with those who are isolated.
- Resources, referrals and case management.
- Shopping needs: Need for affordable groceries and food pantry/mobile food share pick-ups/deliveries, and other shopping needs.
- Educating residents regarding what the definition and importance of quarantining & self-isolation.

Financial distress

- Relief programs rather than deferment.
- Financial assistance (many who lost jobs are struggling to make ends meet i.e. bills, rent, etc.)
- Loss of income due to business shutdown or illness has caused stress for renters, particularly.
- Funding for tenant/landlord resolution, or for rent payments to avoid evictions needed.
- Resources, referrals and case management.
 Job loss/reduction in hours/wages.

Homelessness – Food, clothing, shelter

Homelessness/displacement

- Persons with physical disabilities not suitable for shelters are being evicted due to lack of income (pending Social Security Disability) Need alternative place to live.
- Resources (available units, temporary safe locations).
- Additional funding.
 Rent/mortgage relief programs.
- Placement assistance.
- Addiction treatment.
- Resources, referrals and case management.

Food, clothing, shelter

- Monetary donations to assist with food pantry needs.
- Sheltering assistance for unemployed/homeless.
- Funding assistance.
- Resources, referrals and case management.
- Clothing and hygiene products
- Transportation assistance i.e. grocery store, medication, etc.

Elder and Homebound care

Elder care

- Increase funding to VNAs to expand their services to isolated elders.
- Hoarding and sanitation assistance.
- Adult protective services have limited staff. i.e. if a report needs to be made you must leave a message and wait for a return phone call.
- Struggle for elders to see doctors in person, and inability to utilize technology in its place.
- Resources, referrals and case management.
- Face masks for elderly or frail residents; we have received donations of masks.

Homebound care

- Financial assistance for meal delivery, medical attention, bathing, dressing, food preparation, socialization, etc.
- Resources, referrals and case management.
- Assistance with disabled elder care for disabled child (under 60 yo) requiring constant care and lack of insurance.
- Assistance with daily activities, cleaning, laundry,
- Transportation assistance i.e. shopping, medical appointments, etc.

Persons with disabilities/special needs

- Persons with disabilities/special needs are not suitable for shelters need alternative housing options. (No income, nor social security)
- Virtual meetings are difficult for some with disabilities to participate.
- Resources, referrals and case management.
- Assistance with home care for disabled youths.
- Aides and Home Healthcare workers reluctant to enter the residents' homes leaving them without services.

Medical appointments AND Prescription pick-up

- Patients stressed about having to be seen alone (especially for those that suffer from Dementia or other disorders that require someone to be with them).
- Assistance with prescription pick-up/delivery.
- Resources, referrals and case management.
- Transportation needs.
- Rides to and from, helping residents to understand their diagnosis and care plan. Our residents DO NOT ZOOM or teleconference and most doctors are not "seeing" patients at this time.
- Lack of knowledge on how to use smartphones or computers to utilize telehealth options.

Childcare/Preschool and Childcare Education

Childcare/Preschool

- Critical need for these services to reopen.
- Difficulty working from home and homeschooling at the same time.
- Lack of summer camps and activities are also contributing to the increased stress and lack of resources.
- Financial assistance. (i.e. to help fund summer camps, etc.)
- Resources, referrals and case management.
- Daycare assistance so residents can work.

Childcare education

Resources, referrals and case management.

Addiction and Mental Health

Addiction

- Treatment assistance.
- Resources, referrals and case management.
- Inability to obtain necessary services and treatment i.e AA meetings, etc. are ZOOM and teleconferences, therefore inaccessible to our residents.

Mental Health

- Resources for support groups and/or individual counseling.
 Wait lists may be weeks long.
- Increase access to professional services.
 Additional clinical staffing.
- Treatment assistance; this is a growing problem for all ages.
- Depression, anxiety, addiction, mood instability among others resulting from fear and isolation.
- Resources, referrals and case management.
- Increase in stressors and triggers as a result of the COVID 19 pandemic, need additional support for those with mental health disorders

Domestic Violence

- Access to additional counseling services.
- Temporary relocation of victim. Social Services reports an increase in domestic violence; some relocation needed.
- Financial assistance for those in need.
- Resources, referrals and case management.

Other areas

- More assistance with employment skills/training for persons who are middle aged who have not worked in a long time, as well as case management services for them re: employment needs.
- Establish a hotline for residents to obtain latest information, talk to a counselor or to connect with needed services.
- Resources, referrals and case management.
- Find ways to provide socialization for our senior citizens while keeping them safe (consider limited use of technology, loss of hearing and eye sight, etc.)
