On January 25, 2022, CRCOG is planning to issue a Request for Qualifications (RFQ) to identify qualified firms to serve on the following On-Call Lists for a 36-month timeframe to assist with Local Transportation Capital Improvements Program (LOTCIP) related tasks:

On-Call List 1: Municipal Engineering Design Phase Assistance On-Call List 2: Municipal Engineering Construction Phase Assistance

In 2019 CRCOG established the above on-call lists of consultants to assist municipalities with project delivery. Four consultants currently appear on each list, each with terms that will expire May 31, 2022. Therefore, this RFQ is intended to identify four consultants to serve on each of these lists beginning June 1, 2022 and ending May 31, 2025.

In addition to On-Call Lists 1 and 2, CRCOG is currently contracted with BETA and CHA for On-Call List 3: CRCOG Program Management and Design Review Assistance. These consultants assist CRCOG with program management and peer design reviews. Each of these consultants' terms will expire on May 31, 2022, and staff recommends that each receive a two-year contract extension.

Staff recommends committee approval for a Request for Qualifications (RFQ) issuance in January to identify qualified four firms to serve on each LOTCIP On-Call Lists 1 and 2 for a 36-month timeframe, and to extend each of the two LOTCIP On-Call List 3 consultant's contracts for two-years.
