- **1. Roll Call 0:00** –The meeting was called to order at 12:02 pm by the Chair Jon Colman from the Town of Bloomfield. Karen Stewartson conducted the roll call.
- **2**. **Public Forum 4:15** No one chose to speak.
- **3.** Adoption of Meeting Minutes from April 25, 2022 4:26 A motion was made by Chris Edge from the Town of Berlin, seconded by Eric Anderson from the Town of Andover, to approve the minutes from the Transportation Committee Meeting on April 25, 2022. This motion was passed unanimously with two (2) abstentions made by Todd Rolland from the Town of Somers and Doug Wilson from the Town of East Hartford.

4. Staff Report

- Safe Streets and Roads for all (SS4A) Grant Program 5:20 Mr. Roger Krahn shared some highlights of the Safe Streets and Roads for All (SS4A) grant program. This program includes \$5 billion over five years to spend on initiatives to prevent roadway deaths and serious injuries. The Notice of Funding Opportunity (NOFO) was posted on May 16, 2022 and can be found at https://www.transportation.gov/SS4A. Related webinar recordings and presentation slides are also available on the website. There was a discussion regarding CRCOG's potential role in coordinating applications as well as whether CRCOG's Regional Transportation Safety Plan qualifies as an Action Plan. Mr. Rob Aloise noted that staff hopes to have more details next month, and further discussion may be needed at a Cost Review Sub-Committee meeting.
- Connecticut Ozone/PM2.5 Air Quality Conformity Determination 21:51 Ms. Cara Radzins shared that CTDOT has prepared an Air Quality Conformity Determination for the 2019-2045 Metropolitan Transportation Plans and the 2021-2024 Transportation Improvement Programs. Ms. Radzins noted that Hartford County remains in non-attainment for Ozone and in attainment for PM2.5. The document is available for public review, and CRCOG will be holding a virtual public meeting on June 6, 2022 from 12-1pm. Comments are due by June 20, 2022, and staff will seek action related to this document at the June meeting.
- Commuter Parking Lots Utilization 23:25 Ms. Cara Radzins shared that the commuter parking lot counts conducted in April showed double the number of cars as the average during 2020-2021. While this is encouraging, the April numbers were still approximately half of the pre-COVID utilization. Ms. Radzins noted that it will be interesting to see what the counts show in October.

- Transit Priority Corridors Draft Implementation Strategy 24:560 Ms. Cara Radzins shared that a draft Transit Priority Corridors Implementation Strategy is available for review, and the public comment period will run through June 13, 2022. CRCOG staff is coordinating with Hartford and East Hartford to secure municipal endorsement of the study's recommendations and will seek endorsement by the Transportation Committee (acting as the Policy Board) in July. - Transportation Committee Virtual/Hybrid Meeting Approach 25:47

 Ms. Cara Radzins reported that based on the discussion at the April meeting, CRCOG staff recommends that Transportation Committee continue to meet virtually but with a hybrid option quarterly. The first hybrid meeting will be held on September 26, 2022. Adjustments to this approach can be made as needed if members of the Transportation Committee agree on the need for changes. No committee members objected to this recommendation.
- LOTCIP Financial Review and Next Solicitation 27:29 Mr. Rob Aloise and Ms. Sotoria Montanari shared information about CRCOG's LOTCIP financials, noting a large gap between the amount of funds committed and the amount of funds awarded. There were several discussions about the reasons for the time lag, and there was consensus about CRCOG taking a more aggressive approach to soliciting projects. Mr. Aloise noted that staff will develop a suggested plan for the next solicitation for discussion at next month's meeting.
- **Rural Funding Follow-Up 41:05** Mr. Rob Aloise shared that CTDOT will be initiating a Rural LOTCIP Program. Draft guidelines will be discussed at a meeting between CTDOT and the COGs in June. More information will be shared at the next Transportation Committee meeting.
- CTDOT/COG LEAN Process 42.49 Mr. Rob Aloise shared that CTDOT and the COGs will participate in a LEAN Process in early June. Mr. Aloise stated that the purpose of a LEAN Process is to analyze processes in order to make them more efficient. Mr. Aloise mentioned that he and Matt Hart will be attending on behalf of CRCOG, and topics include the Capital Plan, LOTCIP, additional delegation of programs to COGs, funding, and how COGs interact with CTDOT.
- Other: Updated LOTCIP On-Call Lists 1&2 45:30 Ms. Sotoria Montanari shared that new firms have been selected for LOTCIP On-Call Lists 1 and 2. The complete list and contact information will be posted on the CRCOG website by June 1, 2022 when the new lists go into effect. Ms. Montanari thanked the Committee members who were part of the selection process.
- Other: Reconnecting Communities Grant Program 46.27 Mr. Tim Malone shared information about the new Reconnecting Communities Grant Program. This program includes \$1 billion over five years to spend on removing, retrofitting, mitigating, and replacing eligible transportation facilities that create a barrier to mobility. The NOFO is expected to be released this summer. More information is available at https://www.transportation.gov/grants/reconnecting-communities.
- Other: Executive Director Update 49.30 Mr. Matt Hart shared that CRCOG will be hiring additional staff to coordinate new efforts related to IIJA. He also noted that Steven Nocera will be doing a presentation on IIJA at the Policy Board meeting on May 25, 2022. Mr. Hart stated he will be participating on a panel with Commissioner Boughton on June 3, 2022.

- **5. TIP Amendments 51:20** Mr. Rob Aloise reviewed the TIP Amendments. Mr. Dan Pennington added some information about the project in Glastonbury. A motion was made by Chris Edge from the Town of Berlin, seconded by Dan Pennington from the Town of Glastonbury, to approve the TIP Amendments. This motion was passed unanimously

- **6. Annual Urban Planning Certification Resolution 56:18** Ms. Cara Radzins presented the annual resolution for CRCOG to self-certify that its transportation planning program is compliant with the applicable federal codes. A motion was made by Dan Pennington from the Town of Glastonbury, seconded by Tom Roy from the Town of Simsbury, to approve the Annual Urban Planning Certification. This motion was passed unanimously.
- 7. **Resolution Authorizing Transportation Committee to Act as Policy Board 57:51** Mr. Jon Colman presented the annual resolution to allow the CRCOG Transportation Committee to act on behalf of the CRCOG Policy Board during the summer when Policy Board does not meet but Transportation Committee does. A motion was made by Dan Pennington from the Town of Glastonbury, seconded by Eric Anderson from the town of Andover, to approve the resolution. This motion was passed unanimously.
- **8. Presentation: ezIQC Program 59:06** Ms. Kim Bona gave a brief overview of the ezIQC Program, which is a competitively-bid, on-call service for construction projects. Representatives from the Gordian Group shared additional details about the program, its benefits, and sample projects.
