Project Description (long): Justification: The deck is rated "4" and has numerous hollow areas, spalls, random longitudinal and transverse hairline cracks and concrete repai patches with efflorescence throughout. There are a total of 33 spans on this bridge and it is very likely that some areas of the deck may be replaced while other areas may only require partial or full depth patching. The superstructure has many areas that will require steel repairs to the beam ends along with many bearings that have heavy to moderate rust, laminar rust, impacted rust between keepers and bearing plates and with cracked welds at the keepers. Several elastomeric bearing pads are undermined due to spalls at the pedestal and some bearing sole plates are not in contact with the masonry plates. The substructure is comprised of 2 abutments, 5 piers and 27 Bents with encased piles at ground level. The abutments have isolated hollow areas with previously patched areas that are hollow sounding.
