### **1. Call to Order:**

Chair Erin Stewart called the meeting to order at 12:02 pm

**<u>2. Public Comment:</u>** David Murphy from CIRCA stated that CIRCA will be reaching out to its member towns to meet about Hazard Mitigation Update and Resilient CT.

### 3. Approval of Minutes from January 18, 2023

Jon Colman made a motion to approve the Minutes of the March 22, 2022, Policy Board Meeting. Steve Jones seconded the motion, and the motion carried unanimously.

#### **4. STAFF REPORTS:**

### 5. Legislative Update

According to Ms. Lutz, the assembly is currently undergoing a period of change and it appears that the Governor's Budget will be approved before the end of the session. The upcoming days will provide insight into how the budget is being finalized. Additionally, both the house and senate have announced their session schedules.

Also, according to Steve Stephanou the state will send notices to CMERS Members regarding a tentative agreement that will lower the floor of the COLA, leading to considerable savings for municipalities. John Elsesser stated that there are several proposals that will increase revenue streams for municipalities and that it is important to indicate our support for these measures.

#### 6. Presentation: MyCTSavings, by Jessica Muirhead and Lisa Kidder

The Office of the Comptroller is running a new program called MyCTSavings, which is a retirement savings plan for Connecticut residents that aims to support small businesses and their employees. The program started in April 2022 and has certain rules for both employers and employees.

#### 7. Action: TIP Amendments:

Jon Colman made a motion to approve the TIP Amendments, which have been endorsed by the Transportation committee. Peter Souza seconded, and the motion carried unanimously.

# 8. Action: Endorsement of the listed projects for submission to CTDOT for consideration under the statewide Transportation Rural Improvement Program (TRIP) solicitation

Jon Colman reported that the Transportation Committee has endorsed the four proposed projects for submission to the state and made a motion to approve the same. Lisa Thomas seconded the motion and it passed unanimously.

#### 9. Action: Adoption the 2023-2050 Metropolitan Transportation Plan

Jon Colman presented the final version of the Metropolitan Transportation Plan for the years 2023-2050. The plan underwent public review and was approved by the Transportation Committee. Mr. Colman made a motion to approve, which was seconded by Lisa Thomas. The motion carried unanimously.

#### 10. Action: Conformity with the Clean Air Act for Ozone

Jon Colman reported that the approved Metropolitan Transportation Plan and the Transportation Improvement Program conform to Clean Air Act for ozone. Mr. Colman made a motion to approve, which was seconded by Steve Stephanou. The motion carried unanimously.

Matt Hart briefly reviewed the attached correspondence and asked the members to review latest edition of *The CRCOG Connection*.

No other business was noted.
