

INVITATIONS TO BID FOR INDEFINITE QUANTITY CONSTRUCTION SERVICES

The Capitol Region Purchasing Council is putting out two (2) separate sets of Indefinite Quantity Construction contracting bids: **Construction**, and **Road & Bridge Maintenance**. Each bid will have a mandatory pre-bid meeting on **Wednesday, September 27, 2023**, times indicated below. Bidders must have at least \$1,000,000 in available bonding capacity to qualify for the award. A Plan holder List will be published as it is updated.

eziQC® Construction

The Capitol Region Council of Governments (CRCOG) invites sealed bids for two (2) sets of eziQC® (EZ Indefinite Quantity Construction) contracts for use by Members of the Capitol Region Purchasing Council, a program of CRCOG. These are indefinite quantity, indefinite location construction contracts for renovation, repair, and upgrade projects. There is one contract for each geographic area in Connecticut (Northwest, Northeast, Southwest and Southeast) for a total of eight (8) contracts. Each contract has an estimated annual value of \$1,000,000. A **mandatory pre-bid conference** will be held on **Wednesday, September 27, 2023, at the CRCOG Offices 3rd Floor Board Room, 241 Main Street, 3rd Floor, Hartford, CT 06106** at 9:00 a.m. for **Construction** and 10:30 AM for **Road and Bridge Maintenance**. **Bid documents will be available via BidCentral at the pre-bid conference for those firms attending the pre-bid conference. Bidders must attend the pre-bid conference in order to obtain a set of bid documents.** Bidders must have at least \$1,000,000 in available bonding capacity to qualify for award. Bids are due as follows:

All Proposers will be required to certify that they are not on the Comptroller General's list of ineligible contractors. Further, the contractor will be required to comply with all applicable equal employment opportunity laws and regulations.

This contract is subject to state contract compliance requirements, including non-discrimination statutes and set-aside requirements. State law requires a minimum of twenty-five (25%) percent of the state-funded portion of the contract be set aside for award to subcontractors holding current certification from the Connecticut Department of Administrative Services. The contractor must demonstrate good faith effort to meet the 25% set-aside goals. **ALL BIDS WILL BE DUE ON 10/26/2023 @ 10:00 AM.**
