- 1. **Roll Call o:00** The meeting was called to order at 12:01 pm by the Chair Jon Colman from the Town of Bloomfield. The Zoom participant list will serve as roll call.
- **2**. **Public Forum 0:24** No one chose to speak.
- **3.** Adoption of Meeting Minutes from October 23, 2023 0:50 A motion was made by David Smith from the Town of Tolland, seconded by Devin Cowperthwaite from the Town of Stafford, to adopt the minutes from the Transportation Committee meeting on October 23, 2023. This motion was passed unanimously with three (3) abstentions made by Patrice Carson from the Town of Bolton, Donald Nunes from the Town of Enfield, and Kirk Severance from the Town of Granby.

4. Staff Reports

- 60 Seconds for Safety 2:00
 - o **Crash Responders Safety Week** Terri Thompson shared that Crash Responder Safety Week is November 13-17. The theme "Protect Those who Protect You" will be emphasizing the traveling public's role in keeping responders safe while responders make roadways safe for all road users.
 - o **World Day of Remembrance** Terri Thompson mentioned that a World Remembrance Day event will be held on November 19, from 1-3 pm at Bushnell Park. This event will honor those who were killed by cars. CRCOG, CTDOT, and others are sponsoring the event.

- **BIL/IIJA Update 4:33** Elizabeth Sanderson presented an update on BIL/IIJA funding opportunities and related upcoming events, noting more detailed information is available on the CRCOG website and in the November Funding Opportunities Newsletter. Jon Colman from the Town of Bloomfield asked about opportunities for rural Towns, and Ms. Sanderson shared that FHWA maintains a list at https://www.transportation.gov/rural/funding-opportunities.
- Commuter Parking Lot Utilization -15:42 Cara Radzins gave a brief update on the Fall 2023 commuter parking lot counts. She mentioned there was a small increase, partially due to the addition of a new lot in Farmington. Eric Anderson from the Town of Andover commented on the relationship between limited commuter bus service and limited commuter parking lot usage. Ms. Radzins noted that CRCOG would be happy to help facilitate conversations with CTDOT if additional service is sought by a Town.
- **2024 LOTCIP Project Solicitation Update 19:51** Sotoria Montanari shared that the 2024 LOTCIP Project Solicitation has been released. She reminded the Committee that CRCOG will be selecting \$42 million in projects. Requests for a free, voluntary pavement assessment are due by January 10, 2024, and all applications are due by February 21, 2024 at 2:00 pm.
- LOTCIP Consultant Assistance (On-Call List 3) Request for Qualifications 21:34 Sotoria Montanari shared that the LOTCIP Consultant Assistance (On-Call List 3) RFQ will be distributed on November 29, 2023, with applications due on January 31, 2024 at 2:00 pm.
- **Greater Hartford Mobility Study Public Meetings 22:12** Rob Aloise gave a brief update on the Greater Hartford Mobility Study Public Meetings. He mentioned that the first public meeting was held on November 9 in Hartford and the second meeting will be held on November 16 in East Hartford from 6-8pm in person. He mentioned that the study is proposing a host of improvements across the region and the meeting on Thursday will focus on four major projects which includes freeways, trail, and connectivity in Hartford and East Hartford. Mr. Aloise mentioned that a final report will be coming out at the end of the month.
- Other: Complete Streets Design Criteria Follow-Up with CTDOT 26:04 Anaka Maher noted that CRCOG had relayed the Committee's concerns to CTDOT regarding the Complete Streets Design Criteria. Ms. Maher reviewed CTDOT's responses to these questions, noting that the questions and answers were also posted to the CRCOG website.
- Other: Carbon Reduction Program/TA Set-Aside Funding 28:51 Rob Aloise shared that solicitations for funding under the Carbon Reduction Program and the Transportation Alternatives (TA) Set Aside Program are anticipated within the next six months. CRCOG staff will keep the Committee informed of updates.
- Executive Director Update 31:26 Matt Hart shared that 17 communities across the state received \$11.7 million in Community Connectivity grants. Out of the 17, six (6) were CRCOG municipalities: Berlin, Canton, East Granby, Manchester, New Britain, and South Windsor. Mr. Hart congratulated them on the awards. Mr. Hart also mentioned that CRCOG will be scheduling an orientation for new Policy Board members to provide an overview of CRCOG.
- **5. TIP Amendments 35:53** Rob Aloise reviewed the TIP Amendments. Committee members expressed concern about moving the projects to "FYI"

without a commitment from CTDOT that the projects would be placed in a future year. Cara Radzins explained that this was a procedural issue because the current TIP only runs through FY2024 so there are no future years for projects to be moved to until the next TIP for FY2025-2028 is approved next year. Additional concern was voiced about potentially jeopardizing projects by not acting on the amendments. A motion was made by Russ Arnold from the Town of Farmington, seconded by Rob Trottier from the City of New Britain, to accept the TIP Amendments as presented. This motion was passed unanimously. CRCOG Staff will ask CTDOT to provide additional scheduling information with future TIP amendments that delay projects into the FY2025-2028 TIP.

6. Resolution: 2024 Annual CTDOT Safety Performance Targets - 45:21

- Roger Krahn presented CTDOT's five (5) safety performance targets for calendar year 2024, which were discussed in more detail during the October Transportation Committee meeting. A motion was made by Frank Dellaripa from the City of Hartford, seconded by Suzanne Choate from the Town of Windsor, to support CTDOT's Safety Performance Targets as CRCOG's regional targets for 2024. This motion was passed unanimously.
- 7. **Resolution:** Endorsement of Enfield Traffic Impact Study 47:18 Caitlin Palmer noted that CRCOG staff is seeking endorsement of the Enfield Traffic Impact Study, which has already been endorsed by the Town. A motion was made by Patrice Carson from the Town of Bolton, seconded by Doug Wilson from the Town of East Hartford, to endorse the Enfield Traffic Impact Study and its recommendations. This motion was passed unanimously.
- **8. 2024 Transportation Committee Meeting Schedule 48:38** Cara Radzins presented the draft 2024 Transportation Committee meeting schedule, noting the quarterly hybrid meetings and that Transportation Committee would only act as Policy Board in July because of Policy Board's new schedule. A motion was made by Patrice Carson from the Town of Bolton, seconded by Doug Wilson from the Town of East Hartford, to accept the 2024 Transportation Committee meeting schedule. This motion was passed unanimously.
- 9. Presentation: State Local Bridge Program-Andrew Shields, CTDOT 50:36 Andrew Shields, a Project Engineer at CTDOT, gave a presentation on the State Local Bridge Program. This program offers dollar for dollar matching grants to rebuild failing bridges in Connecticut (State General Statute Ch 240, Sect 13a-175q).
