## Capital Region Council of Governments (CRCOG) Gap Foundation Funding Application Process

<u>Important Note:</u> If you are further along with the CFSIC process, **DO NOT sign a construction contract!**If you sign a construction contract prior to approval of the Gap Foundation Funding, you will be ineligible to participate in our program.

- 1. **Claim Registration Number** If you have not already applied to the Connecticut Foundation Solutions Indemnity Company, Inc, (CFSIC) you must apply at <a href="https://crumblingfoundations.org/">https://crumblingfoundations.org/</a>.
  - a) Once you receive a "claim registration number" you can then apply for Gap Foundation Funding.
- 2) **Review Family Income Eligibility** Go to the following link through the Capital Region Council of Governments (CRCOG) for Gap Foundation Funding <a href="https://crcog.org/gap-foundation-funding/">https://crcog.org/gap-foundation-funding/</a>. This link will include a Family Income Eligibility Summary. This document outlines the maximum family income based on family size and location. Review this form to see if your household might fall within these parameters.
  - a) If you believe you might qualify you can then move forward to complete the Pre-Application/Self-Reported Income Input/Form.
- 3) **Pre-Application/Self-Reported Income** Go to the following link through the Capital Region Council of Governments (CRCOG) for Gap Foundation Funding <a href="https://crcog.org/gap-foundation-funding/">https://crcog.org/gap-foundation-funding/</a> Complete the **On-line Pre-Application/Self-Reported Income Form.** If you cannot complete or prefer not to complete this form online you can also obtain/submit the form in one of the following ways:
  - a) Print the PDF version of **Pre-Application/Self-Reported Income Form**, fill it out and e-mail it to *GapFoundationFunding@HDTLLC.com*
  - b) Print the PDF version of **Pre-Application/Self-Reported Income Form**, fill it out and fax it to it to **203-549-0750**.
  - c) Print the PDF version of **Pre-Application/Self-Reported Income Form**, fill it out and mail it to *Housing Development Team LLC*, 2505 Main Street, Suite 201, Stratford, CT 06615
  - d) Request a Hard copy version mailed to you by leaving a voicemail at 203-362-5787. You can then submit it via e-mail, fax, or mail as described in a), b), or c) above.
  - e) \*\*\* It is important to note that Pre-Applications are time/date stamped for priority. The On-Line version is the fastest was of submission.
- 4) **Staff Review** of **Pre-Application/Self-Reported Income** submission.
  - a) Identify missing or request additional information for Pre-qualification.
  - b) Make Determination of Pre-qualification and provide *Income Verification Checklist*.
  - c) Contact applicant to set up Phone Conference for verification and approval.
- 5) Phone Conference with applicant to move toward full application file & 3<sup>rd</sup> party verification.
  - a) Confirmation of Pre-Application Details
  - b) Review *Income Verification Checklist* of items to complete application file
  - c) Follow up call if needed.
- 6) Site Visit/meeting/review for Hard copy documentation
  - a) Staff to meet on site with applicant to obtain required checklist in items from #5 above.
- 7) Final Review and 3<sup>rd</sup> Party Verification.
  - a) Review all documentation to complete the required income qualification file.
  - b) Request 3<sup>rd</sup> party verification and approval
- 8) **Issuance of Funding Commitment Letter**. Once the Funding Commitment Letter is issued, you may sign a construction contract.
